- City of Easton Project:
 - Part A:
 - The contractor has completed the installation of the new 24" water main on 4th St. between Spring Garden St. and Ferry St.
 - The contractor has approximately 800 feet of 24" main and 600 feet of 16" main left to install.
 - The contractor began saw cutting the trenches in order to begin trench restoration work on August 4, 2011, starting at the intersection of Cattell St. and High St.
 - The contractor will proceed south on Cattell St., west on College Ave. and south on Third St. to the intersection with Spring Garden St. The trench restoration work should be completed by August 19, 2011.
 - The milling and overlaying of Cattell St., College Ave. and North Third St. will be performed once all trench restoration has been completed, all ESWA ADA ramps have been installed on Cattell

St. and all City of Easton ADA ramps and trench work has been completed on North 3^{rd} St.

- Part B & C:
 - All water system work has been completed in Parts B and C.
 - All trench restoration work has been completed in Parts B & C.
 - The contractor is completing the concrete restoration (sidewalk) work on Butler St. and should be completed with the concrete restoration work on 9th Street by August 12, 2011.
 - The milling and overlaying of the streets will begin once the ADA ramps have been installed.
- Davis Street Pumping Station:
 - The General and Electrical Contractors are now working on installing the remaining internal components to the station.
 - The SCADA equipment will not be shipped until September, so start up of the pump station will not occur until early October.
- ADA Ramps:
 - Heim Construction began work on the ADA ramps on Cattell Street on Tuesday, August 2, 2011. They anticipate the work on Cattell Street taking approximately 3 weeks to completed, after which they will complete the work on the remaining PennDOT ramps and then complete the ramps on 4th Street.
 - F.A. Rohrbach began work on the ADA ramps on Wilkes Barre Street on July 25, 2011. They anticipate the work on Wilkes Barre Street taking approximately 3 weeks after which, they will begin their work on Berwick Street.

 - All water system work has been completed.
 - All trench restoration work has been completed.
 - Lieberman Terrace Water Main Improvements:
 - Water Main installation began in the middle of July and was completed on July 28, 2011.
 - The water main will be pressure tested, flushed and sampled during the week of August 1, 2011.
 - The service lateral reconnections will be made once the water main has passed all required tests.
 - Mitman Road Water Main Improvements:
 - The property owner at 1009 Mitman Rd. had ESWA personnel install an 8" water main extension at their expense in order to receive public water service.
 - The main extension was completed in early July and the service lateral and water meter has since been installed.
