 - Flushing in the Knox Avenue South System, which includes the area of Bethlehem and Palmer Townships east of Route 33 and south of Route 22 was completed on June 17, 2013.
 - Flushing was started in the Suburban 15th Street System, which includes the Boroughs of West Easton and Wilson, on June 19, 2013 and is scheduled to be completed on July 23, 2013.
 - Flushing will begin in the Knox North System, which includes the southwestern portion of Forks Township and northern portion of Palmer Township, once the Suburban 15th Street System is completed.

 - o Front Street & Keystone Avenue Pressure Chamber
 - The pressure control valve manufacturer's representative was on site on Monday, June 10th and the valve has been placed in service.
 - o Palmer Tank Altitude Valve
 - Facility Personnel are working on relocating the electric panel and SCADA equipment from the old chamber to the new chamber.
 - Once all of the equipment is moved to new chamber, the driveway will be repaved.
 - Mine Lane Road Improvements
 - Water Main Installation and testing completed the week of June 10th.
 - Service laterals were transferred from the existing 6" cast iron main to the new 8" ductile iron main during the week of June 24th.
 - The new 8" water main on Mine Lane Road will be connected to the existing water main on Glen Avenue and Southwood Drive during the week of July 1st.
 - The fire hydrants at the intersection with Southwood Drive and Glen Avenue will be removed and connected to the new 8" water main during the week of July 1st.

- o Northwood Avenue Improvements
 - On Friday, June 14th, work began to transfer the service laterals from the 6" water main to the 16" water main.
 - Replacement of the 16" water main began on Monday, June 17th, with the replacement of the 16" water main being completed on Tuesday, June 18th and testing being performed on Wednesday, June 19th.
 - Service lateral transfers to the 16" water main were completed on Monday, June 24th.
 - The trench pavement restoration was completed on Tuesday, June 25th.
 - The road was reopened on Thursday, June 27th, once the pavement markings were repainted on the disturbed areas of the pavement.
 - The final pavement restoration (wearing course replacement) will be performed in late summer/early fall.
