- Flushing
  - Flushing was completed in the North High System, which includes most of Forks Township on September 14, 2012.
  - Flushing was performed in the Morgan Hill High Service System, which includes the Morgan Hill Golf Course Community in Williams Township on September 15 & 16, 2012.
  - Flushing was performed in the Suburban Morgan Hill System, which includes Williams Township and the Borough of Glendon, between September 17 & 20, 2012.
  - Flushing started in the Lower Nazareth System on September 21, 2012 and is scheduled to be completed on October 15, 2012.

- Authority Projects
  - City of Easton Improvements
    - Contract I: Part A
      - The close-out documents are being prepared for the contract.
    - Davis Street Pumping Station
      - The contractors have been provided with a small punch list of items that must be addressed before the contracts can be closed out.
    - ADA Ramps
      - The close-out documents are being prepared for the contract.
  - Wilden Acres Phase II Improvements
    - ESWA personnel completed the water system work on Freemansburg Avenue and Whitney Avenue, and pavement restoration should be performed by the end of October.
    - ESWA staff is working with Palmer Township to use a portion of the Bike Path right-of-way to install the new water main. Once the route is finalized, a schedule will be completed for the work.
  - o Palmer Tank Painting and Modifications
    - The tank contractor has completed the steel work and has begun painting the exterior tank, which should be completed by October 12<sup>th</sup>.
    - Once the exterior has been completed, the contractor will begin painting the interior, which should take an additional two weeks.
    - Based on this schedule, the work should be completed in late October with the tank being place in service in early November.
  - o Palmer Tank Altitude Valve Chamber
    - ESWA personnel installed a new 16" x 16" tee with 16" butterfly valves on the street side of the existing valve chamber. This work was coordinated with the draining of the Palmer Tank.

- A 16" x 16" tee and butterfly valves will be installed on the tank side of the existing chamber as the tank contractor work permits. This will be done before the tank is placed back in service after being painted.
- The new chamber and altitude valve are being ordered by ESWA staff and are scheduled to be installed in November.
- Green Pond Road/Greenwood Avenue Improvements
  - ESWA personnel completed the installation and testing of the new water main in September.
  - The service laterals have been transferred to the new main and the galvanized main on Greenwood Avenue was abandoned in the first week of October.

### **Executive Committee –**

# **REPORT OF SOLICITOR**

Attorney Walters stated that the Ziegler case has been scheduled for trial on the Monday after Thanksgiving before Judge Koury. Craig Swinsburg and Mark Bonstein will be participating as witnesses for the Authority.

Attorney Walters also reported there is a case by the Commonwealth Court that expands the Right to Know Act that expands the definition of a public document to include an email sent from a personal computer to another personal computer.

Attorney Walters also reported on a change to the Authority's Rules and Regulations, Section 11, Paragraph B, on when a bill becomes delinquent. The Authority will no longer use the United States Post Office mark as evidence that the bill is paid on time, and bills will be due by the end of business day on the due date specified on the face of the bill.

On a motion from Mr. Colton, seconded by Mr. Lockard, the Rules and Regulations were changed to reflect the change in policy on Section 11, Paragraph B, on when a bill becomes delinquent, to become effective on January 1, 2013, with notification to customers starting immediately.
