Authority Projects

- Wilden Acres Tank Painting
 - Tank Taken out of service Monday September 14th.
 - Pro-Spec mobilized in late September.
 - Interior blasting and painting starting on October 12th.
 - Substantial completion (tank back in service) deadline is December 1st.
 - Hodle Avenue
 - ESWA replacing 1,500' of 6" cast iron main with 8" ductile iron water main.
 - Water system work began on September 11th and was completed on October 8th.
 - The trenches have been temporarily restored.
 - Permanent trench restoration will be performed in the Spring of 2017.

- Morgan Hill High Service Pumping Station
 - Pump 3 was removed on August 3rd, rebuilt by Kohls Brothers and reinstalled on September 23rd.
 - After the pump was reinstalled, it was determined the starter for the pump was also damaged and needed to be replaced.
 - The starter is on order and should be reinstalled the week of October 12th.
 - The rebuilding of pumps 1 and 2 will be performed in late 2015 / early 2016.
- Lower Nazareth Pump Station
 - Met with Northampton County Staff on September 15th to discuss possible pump station location at Louise Moore Park.
 - ESWA would construct water main on Country Club Road in exchange for easement/property to construct pump station on.
 - ESWA requested proposals for survey and engineering work to create the proposed easements. Requesting approval today.
- Berks Street Project
 - ESWA replacing 850' of 6" unlined, cast iron main with 8" ductile iron water main.
 - Several main breaks in recent years and high amount of internal corrosion.
 - Work is scheduled to begin the week of October 19th and should be completed in the middle of November.
 - Palmer Township will be overlaying the street in 2016.
