- Flushing
 - Flushing was completed in the Knox Avenue North System on August 3,
 2012. This includes the portion of Palmer Township north of Route 22 as well as the southwestern portion of Forks Township.
 - Flushing was completed in the Knox Avenue Central System on August 13, 2012. This includes the portion of Palmer Township that is north of Route 22, east of Greenwood Avenue and south of Park Avenue and the Bushkill Creek.
 - Flushing began in the North High System, which includes most of Forks Township, on August 14, 2012 and is scheduled to be completed on September 14, 2012. Flushing in this system will be completed prior to the Plainfield Tank being taken out of service for repairs and painting.

- Authority Projects
 - o City of Easton Improvements
 - Contract I: Part A
 - The subcontractor returned the week of August 20th to repair the cracks in the crosswalks at the intersection of Cattell Street & March Street.
 - A few minor punch list items must be addressed and then the contract will be closed out.
 - Davis Street Pumping Station
 - The contractors have been provided with a small punch list of items that must be addressed before the contracts can be closed out.
 - ADA Ramps
 - F.A. Rohrbach
 - All of the ADA ramps have been completed.
 - The remaining crosswalk and stop bars were painted in August.
 - o Wilden Acres Phase II Improvements
 - ESWA personnel installed a new 12" x 8" cross with valves at the intersection of Freemansburg Avenue & Whitney Avenue.

- ESWA personnel are working to install a new 12" water main on Whitney Avenue between Freemansburg Avenue and Butternut Lane
- ESWA staff is working to finalize the route for the proposed improvements which will be performed in 2012 and 2013.
- o Palmer Tank Painting and Modifications
 - The Palmer Tank was taken out of service on August 23, 2012 and finished draining on August 25, 2012.
 - The tank contractor began steel work on August 27, 2012, cutting in the new access hatches and removing the old ladder.
 - The work is anticipated to take 6 to 8 weeks so the tank should be placed back into service by the end of October.
- o Palmer Tank Altitude Valve Chamber
 - ESWA personnel installed a new 16" x 16" tee with 16" butterfly valves on the street side of the existing valve chamber. This work was coordinated with the draining of the Palmer Tank.
 - A 16" x 16" tee and butterfly valves will be installed on the tank side of the existing chamber as the tank contractor work permits.
 This will be done before the tank is placed back in service after being painted.
 - The new chamber and altitude valve are being ordered by ESWA staff and are scheduled to be installed in October/November.
- o Green Pond Road/Greenwood Avenue Improvements
 - ESWA personnel will be installing 500' of 8" DIP on Greenwood Avenue in order to replace the existing 2" galvanized main in this area.
 - Water main installation is scheduled to begin in September, with water system work being completed in October.
- Water Treatment Plant
 - High Service Pump Replacement
 - Board selected Option 2 at the August 23rd Special Meeting
 - Other unresolved project issues being dealt with
