 - Flushing started in the Knox Avenue South System, which includes the area of Bethlehem and Palmer Townships east of Route 33 and south of Route 22, on May 16, 2013. This area should be completed on June 18, 2013.

 - Facility Personnel are working on relocating the electric panel and SCADA equipment from the old chamber to the new chamber.
 - Once all of the equipment is moved to new chamber, the driveway will be repaved.
 - Mine Lane Road Improvements
 - ESWA Personnel with assistance from a contractor will replace approximately 900 feet of 6" cast iron main on Mine Lane Road between Southwood Drive and Glen Avenue. ESWA has had three main breaks in a 100 feet stretch since December of 2012.
 - Main installation is scheduled to begin on Jun 10th and the water system work should be completed by June 21st.

 - ESWA Personnel with assistance from a contractor will perform water system work on Northwood Avenue between Tatamy Road and Northridge Court beginning on approximately June 12th. The work will consist of the following:
 - Replacement of 400' of 16" main in area of 4/4/13 leak. This is being done to ensure the water main has proper bedding.
 - Transfer of 20 service laterals from the existing 6" water main to 16" water main.
 - Abandonment of 6" water main between Tatamy Road and Northridge Court (1400 feet).

REPORT OF COMMITTEES

Executive Committee –

Mr. Cain, Chairperson, stated that the Executive Committee met prior to the Board Meeting to discuss routine business matters as well as engineering proposals, the Northwood Avenue Project, and the Water Treatment Plant issues with Fairbanks Morse.

Budget and Finance –

Mr. Bergren, Chairperson, stated that the 2012 Audit was distributed to board members and the Budget and Finance committee met with Palmer & Co. on the preliminary audit and the numbers match those supplied at monthly Board Meetings. He recommended that Board Members review the footnotes, and Keith Fleming will be at the July Board Meeting to review the audit report with all Board Members.

Mr. Bergren also stated that the committee will be meeting later in June to develop a procedure for check signing approval.

Attorney Walters stated he has two items to report, the first relating to the claim against Fairbanks Morse and litigation support to be discussed in executive session. The second item is asking for approval for a contract with the State Police to allow them to place antennae on top of the Morgan Hill High Tank.

NEW BUSINESS

Mr. White, Executive Director, stated that he would like approval of an Engineering Services Proposal related to a Hydraulic Study for Lafayette College done by Gannett Fleming at the cost of \$28,500. The study will be done in tasks and the first part will study and analyze the effectiveness of the college's infrastructure, then it will look at our infrastructure and determine what needs to be done by both ESWA and Lafayette College to continue to provide water to the college to meet their needs.

On a motion from Mr. Walker, seconded by Mr. Colton, the Board approved the expenditure of \$28,500 to hire Gannett Fleming to perform the Hydraulic Study of Lafayette College. No public comment was received.

Craig Swinsburg, Assistant Executive Director, stated that he would like approval for an upgrade of the hydraulic model to an Extended Period Simulation Model. The upgrade will provide the Authority with better operations and a 24-hour view of modeling instead of just snapshot views that are available with the current model.

On a motion from Mr. Veresink, seconded by Mr. Bergren, the Board approved the proposal for the Extended Period Simulation Modeling to be done by Gannett Fleming at a cost not to exceed \$16,100. No public comment was received.

Attorney Walters stated that he would like approval for a license agreement with the state police for antennae to be placed on top of the Morgan Hill High Tank. No money will be collected by the Authority for this agreement, but we can terminate the agreement at any time with 60 day notice. The state police will be indemnifying the Authority from any losses that may occur as a result of placing the antennae.

On a motion from Mr. Colton, seconded by Mr. Lockard, the Board authorized the officers to execute the license agreement with the Pennsylvania State Police to place antennae on top of the Morgan Hill High Tank. No public comment was received.

EXECUTIVE SESSION
